If you are interested in being considered for the Nomination Slate, the process is as follows:

The petition process allows members to add their name to the slate by submitting a petition to the CCNLI Committee within 30 days of the announcement.

# PETITION PROCESS REQUIREMENTS:

- For a statewide position, the petition must include signatures from at least 2% of the total number of chapter members. Of that total, 2% must come from each of a majority of the branches in the chapter.
- For a branch position, the petition must include signatures representing 2% of the total number of branch members.
- The CCNLI must verify that petition signers are members of the Association, the chapter, and in the case of branch positions, the appropriate branch.
- The CCNLI must verify that the petition contains the number of eligible signatures required for the specific position for which it has been submitted.

Dear Colleagues,

"Career Protection" is having a professional association with the resources to protect the practice of social work. Why is malpractice insurance not enough? Because your malpractice insurer will not do the following - but NASW at the national level and through the Louisiana Chapter will:

- Provide consultation on ethical, practice, and career issues.

# **Continuing Education Requirements**

Registered Social Workers, Certified Social Workers, Licensed Masters Social Workers, and Licensed Clinical Social Workers are required by law to collect at least twenty (20) hours of continuing education in approved programs each year with three (3) hours of ethics every two years. For the LCSW, ten (10) of the twenty (20) hours must be of clinical content including diagnosis and treatment. The current collection period is July 1, 2017 through June 30, 2018. Beginning July 1, 2008, first time Board Approved Clinical Supervisors (BACS) must complete six and one half (6.5) hours of LABSWE approved clinical supervision education. All other Board Approved Clinical Supervisors (BACS) must complete three (3) hours of continuing education in clinical supervision every two years. Workshops are designated as ethical, clinical, general and supervision in content and meet the Louisiana State Board of Social Work Examiner requirements for licensure renewal.

# Carmen D. Weisner, LCSW, ACSW

# 2018 Social Worker of the Year

Carmen D. Weisner graduated from Louisiana State University with her Master of Social Work degree in 1974. With over forty years of post-masters practice experience and two pre-masters, Ms. Weisner has worked in a variety of social work settings. She began as an eligibility worker in a parish welfare office, and after earning her MSW, became a child protection caseworker providing investigatory and treatment services. Thereafter, she became the lead planner for the development of policy and procedures for the Louisiana Medicaid Program, and then served as the Medicaid Management Information System Claims Processing Manager; later Ms. Weisner was on loan as a Federal Medicaid Quality Control Lead Representative assigned to the state of Arkansas providing management and supervision services. Carmen then managed an annual budget of over \$67 million as the Physician Program Manager for the Louisiana Medicaid Program assuring program compliance under Title XIX regulations. Then for the next sixteen years Ms. Weisner's focus was in the area of child welfare service delivery, financing of public agency service provision and administrative management of programs within the Office of Community Services (Louisiana's public child welfare agency). Ms. Weisner then served as the Assistant Secretary of the Office of Community Services responsible for a \$218 million budget and Human Resource management. A few of the accomplishments during Ms. Weisner's tenure are:

- Accreditation from the Council on Accreditation for Children and Family Services one of
  only three state administered public child welfare agencies achieving this credential. The
  process involved a comprehensive review of the policies and practices of the agency in
  casework protocols, budgeting, record keeping, management of human resources,
  development of a CQI (Continuous Quality Improvement) system, etc.
- Implementation of the Adoption and Safe Families Act in Louisiana. Required extensive coordination with Louisiana's judiciary, legislature, and agency staff.
- For three years the agency received a federal bonus for adoptive placements. The average number of adoptions annually was 450.
- Successfully passed a major federal review that assured continued Title IV-E funds.
- Designed and piloted a level of care reimbursement process for foster care.

Thereafter, Ms. Weisner became the Executive Director of the Louisiana Chapter of the National Association of Social Workers – where she remained at the helm for thirteen years!

Ms. Weisner has served on many boards, task forces, committees, and work groups giving tirelessly of her experience, knowledge, talent, wisdom and humor.

# Gary Tiemann, LCSW, ACSW

# 2018 Lifetime Achievement

Gary Tiemann graduated from Louisiana State University with his Master of Social Work degree in 1987. With over thirty years of post-masters practice experience, Mr. Tiemann has dedicated his career to the mental health field. Before obtaining his MSW, Mr. Tiemann was a volunteer at The Phone, a suicide hot-line in Baton Rouge; he also was an intern with the Mental Health Team at Louisiana State Penitentiary at Angola. After Mr. Tiemann received his MSW, he was a therapist and case manager for the SWIFT (Six Weeks Intensive Family Therapy) program at the Family Crisis Center in Shreveport, moving on to Program Director. He was a partner and served as President of the Board of Directors of a non-profit agency – the Family Empowerment Center. Thereafter, he accepted a position with Charter Forest Hospital as staff psychotherapist and case manager for adults. Not too long after working in that capacity, he was appointed Program Administrator where he managed all the psychiatric units – child, adolescent, adult – and the adolescent chemical dependency unit. Mr. Tiemann moved on to become Clinical Director at Fairfield Hospital, a private in-patient hospital where he designed, implemented and managed the adult psychiatric unit and oversaw the adult chemical dependency unit. Since 1992, Mr. Tiemann has been in private practice providing psychotherapy to individuals, groups, couples and families.

He was a BACS for many years providing post-graduate supervision of social workers; he taught a social work course while a colleague was on maternity leave; he has been an advocate at the state and national level advancing reform efforts for social work consumers; and he has conducted numerous continuing education workshops for the Shreveport Region as well as for NASW-LA at the annual conference.

Recently, Mr. Tiemann wrote and published <u>Miraculous Psychotherapy</u>: <u>Achieve Your Ultimate Happiness with *A Course in Miracles* wherein he synthesizes standard theories of psychology and recounts personal stories and utilizes examples from his practice. He conducts workshops around Louisiana on the science and evidence of reincarnation.</u>

Mr. Tiemann served as a consultant on a movie filmed in Shreveport - The Tale - to be released this year. The movie involves child sexual abuse; the industry standards recommend that a social worker be on the set when a child is on the set when those scenes are filmed to ensure that the child is not exposed to anything inappropriate.

Mr. Tiemann has been a member of the National Association of Social Workers since 1987. He has served on the Louisiana Chapter Board and as Chair of the Shreveport Region. He is also a past recipient of the Dorothy Schenthal Award for Leadership for the Shreveport Region of the Louisiana Chapter. Mr. Tiemann is also a member of the Louisiana Association of Clinical Social Workers (since 1989) currently serving on the Board and is a past President of the Board. He also is a member of the American Society of Clinical Hypnosis (since 1991).

Mr. Tiemann is a long-time member of the League of Women Voters having served on the Board of the local chapter a few years ago. He spent many years coaching youth basketball while his son and daughter were in elementary and junior high school.

# **Glory Deaton**

# 2018 BSW Student of the Year

Glory Deaton is a senior at Northwestern State University finishing her internship at a school based health clinic. Ms. Deaton did not plan on being a social worker – her first major was elementary education. However, she became a bit disillusioned when she discovered that children were expected to learn in the same way. Assessing that this could make school very difficult for some children and is a factor in behavioral problems, she decided to help children cope and to advocate for them with teachers, school administrators, and even parents. When Ms. Deaton changed her major to social work, she forfeited her Gallaspy Scholarship. However, according to Ms. Deaton "something clicked – I felt somewhat like a baby bird, finally discovering the use for its wings . . . I simply have fallen in love with all the possibilities that being a social worker entails and the sheer diversity of this helping field."

Ms. Deaton is well-liked by both faculty and staff at NSU – she always has a big smile on her face. She will graduate with academic honors – currently her GPA is 3.769; she will also graduate debt-free – managing to do so through a combination of TOPS and employment and a small scholarship for working in Boys and Girls state one summer. Ms. Deaton is a member of the NSU rowing team (in 2016, the team ranked 2d nationally in Collegiate Rowing-Four Boat); participation on the rowing team requires daily practices – a major time commitment. This year Ms. Deaton is responsible for freshman recruitment for the team and keeping her team's social media sites current. She is also a member of Alpha Lambda Delta Honor Society.

Ms. Deaton is aware that many students come to NSU (and elsewhere) without the supportive and loving background her family has provided her. According to members of the NSU faculty, "She understands how different and how difficult some people's lives are, realizes that she has been blessed, and frequently exhibits the qualities of gratitude and humility. When we told her that we planned to nominate her for this honor, she cried and then started telling us who she thought was more qualified."

Ms. Deaton is well on her way - "My amazing teachers at Northwestern State have opened up a whole new world of understanding for me. I know that social work is a field where one never stops learning. I intend to further my education by going to graduate school. I have hopes of either opening my own practice or working at a school-based health center as a counselor; I want to do my own research and build on the knowledge I have gained at Northwestern. I know that I am meant to be in this field and I am so excited to begin my career as a social worker."

Judge Pickett was born in Washington, D.C.; he received a Bachelor of Science Degree in Business Administration from Virginia Union University and in 1993 a Juris Doctorate Degree from Southern University Law Center. Before being elected to the bench, Judge Pickett served as an Assistant District Attorney in Terrebonne Parish for over twenty-one years.

Judge Pickett is passionate about the future and safety of our children. He visits schools on a regular basis to discuss with students the importance of a good education, staying off drugs, and staying out of trouble through the Judges in the Classroom, Project LEAD, and the Head Start Programs. Judge Pickett initiated the Judge for the Day Program in his courtroom where junior and high school students shadow him for a day, sitting beside him on the bench, learning about the judicial branch of government on the local level while experiencing the legal system from the judge's perspective.

Judge Pickett is an active member of the Kappa Alpha Psi Fraternity where he assists with the youth Guide Right Program. He also gives an annual scholarship to a deserving senior from Ellender Memorial High School.

Judge Pickett and his wife, Bernadette, whom he met in law school, are the proud parents of one daughter, Jessica.

# Dr. Harry Blake

# 2018 Public Citizen of the Year

The Reverend Dr. Harry Blake was born in Arkansas and moved to Louisiana at a very young age. He received his undergraduate degree from Bishop College in Dallas, Texas; he received the Honorary Doctorate of Humanities from Louisiana Baptist University. Dr. Blake has been pastoring for over sixty years; currently he is the Pastor of Mount Canaan Baptist Church in Shreveport, where he has served for fiftyone years. Mt. Canaan is one of the leading and largest churches in Shreveport; the membership is a culturally diverse body of more than 2,000 sisters and brothers in Christ.

When you think "Civil Rights", of course most of us think of Dr. Martin Luther King; but Dr. King hired a young man in 1960 who lived in Shreveport, Louisiana to spearhead civil rights and equality efforts. as well as head the voter registration drive for African-Americans in Louisiana, Mississippi and Arkansas – his name is Harry Blake. During these tumultuous and dangerous times, as well as throughout the years thereafter, Dr. Blake's accomplishments have been numerous. To name just a few: He has formed alliances with local community leaders and Shreveport city officials to revitalize the Allendale Community. Under his leadership, Mt. Canaan has built multi-level housing for the poor and an apartment complex for the elderly and physically challenged; created the Grace Project which builds single family homes; opened the Mt. Canaan Day Care and created an academic program - the Canaan Boys Academy. Dr. Blake has served in leadership positions over the years with many organizations that champion social change, education, community transformation, and service to and on behalf of the disenfranchised. Dr. Blake has also done much to deter crime; it is reported that the crime rate in the Allendale community – where Dr. Blake's church has been established - is the lowest in Shreveport. In one of the letters received in support of Dr. Blake's nomination for this award, he was described as "a prophetic pastor; passionate leader, social activist and humanitarian; eloquent orator and educator engaged in preaching the gospel of Jesus Christ, in fighting against racial injustice; committed to economic justice and empowerment in under-served communities and touching and transforming the lives of the disenfranchised."

Dr. Blake has also endured consequences as a result of his courageous work: He was arrested numerous times during the Civil Rights Movement - the first arrest was on his very first day of work with Dr. King on March 1, 1960. He was beaten several times while participating in organized nonviolent demonstrations – the most vicious encounter was when police stormed into worship services at Little Union Baptist Church where Dr. Blake organized a service to memorialize four girls who were killed in the Sixteenth Street Baptist Church on September 15, 1963. Dr. Blake was dragged through the church and beaten with nightsticks. On October 12, 1963, there was an assassination attempt as he was shot at on a rural highway as he left his church. Dr. Blake missed opportunities to pastor some churches during this time in history given the level of concern that those churches would be burned or destroyed.

Dr. Blake has in the past and currently does serve on many boards, commissions, and works with many organizations that serve the community. Also, he is a guest lecturer for many Baptist colleges and seminaries. He is married to Norma Jean Jernigan and has four children and sixteen grandchildren. According to two Past Lt. Governors of Kiwanis International.

After serving as Lieutenant Governor, Mr. Guedry accepted an even greater challenge. He was asked to direct the activities of Circle K International Clubs on college campuses throughout the three-state district. In that capacity, he has worked tirelessly to rebuild CKI into a force for good on college campuses. He is a humble man, and would never tell anyone how much of his own funds he has spent organizing CKI district conventions, but those who know him well know that he spent copiously purchasing prizes, planning entertainment, and in general encouraging collegians to become a part of an organization dedicated to helping others.

The mission statement for Kiwanis International reads: "Kiwanis is a global organization of volunteers dedicated to improving the world one child and one community at a time." Sid Guedry epitomizes that noble statement. He has gone out of his way to help improve his community.

Mr. Guedry is always eager to give to worthy causes, to financially support others, and to donate funds to those in need. He has been a longtime financial supporter of St. Thomas Aquinas Regional Catholic High School and Holy Ghost Elementary Catholic School; he financially assisted students at those schools who came from backgrounds of limited resources.

He has opened his mind, his heart, and his wallet to help others. He is a generous, civic-minded servant who is willing to put others above himself.

- 1. When does the new NASW Code of Ethics go into effect? The new NASW Code of Ethics goes into effect on January 1, 2018.
- 2. Where can I get a copy of the revised NASW Code of Ethics? Copies of the revised NASW Code of Ethics will be available by November 1, 2017. You can pre-order a copy by calling NASW Press at 800.227.3590.
- 3. Which sections of the NASW Code of Ethics were updated?

The sections of the NASW Code of Ethics that were revised include:

# 4. What educational resources are available to explain the latest revisions to the NASW Code of Ethics?

Several resources will be available, including an online training, an NASW chat, a blog, code revision consults, and a posting of the changes with the explanations on the NASW website.

# 5. Which social workers are accountable to the NASW Code of Ethics?

Most social workers are held accountable to the NASW Code of Ethics, including NASW members, many licensed social workers, employed social workers, and students.

# 6. Do these changes affect social workers who aren't members of NASW?

Yes. The NASW Code of Ethics sets forth the values, principles, and standards that guide the profession as a whole. NASW members are formally bound to the NASW Code of Ethics, and social work licensees are also accountable as many states incorporate the Code of Ethics into their licensing statutes.

7. Who was responsible for revising the NASW Code of Ethics?
An NASW Code of Ethics Review Task Force was appointed by the NASW
President and approved by the NASW Board of Directors.

# 8. How am I held accountable if I do not implement these changes by the effective date?

If you are a member of NASW, you may be held accountable through the NASW professional review process, if someone files an ethics complaint against you. You may also be held accountable by a state licensing board if a licensing board complaint is filed against you. Furthermore, you may be held accountable by your employer or your university, which may take disciplinary action for failure to adhere to the NASW Code of Ethics. Finally, you may be held accountable through a court of law that looks to the NASW Code of Ethics to establish the standard for professional ethical social work practice.

# 9. Have social work schools, employers, agencies, etc., been made aware of the changes?

NASW is working diligently to notify the social work profession and stakeholders using various communication channels, including print, social media, and web-based notices.

# 10. Who do I contact if I have additional questions?

The resources described in section four above should resolve most questions about the revisions. # Delegate Assembly Approves Revisions to the NASW Code of Ethics

On Friday, August 4, 2017, the Delegate Assembly of the National Association of Social Workers (NASW) approved the most substantive revision to the NASW Code of Ethics since 1996. After careful and charged deliberation, the Delegate Assembly voted to accept proposed revisions to the Code that focused largely on the use of technology and the implications for ethical practice.

The NASW Code of Ethics continues to be the most accepted standard for social work ethical practice worldwide. With emergent technological advances over the last two decades, the profession could not ignore the necessity for more clarity around the complex implications of new forms of communication and relationship building through technology. As such, in September 2015 an NASW Code of Ethics Review Task Force was appointed by the NASW president and approved by the NASW Board of Directors.

The Task Force was charged with examining the current *Code of Ethics* through the lens of specific ethical considerations when using various forms of technology. In September 2015, they embarked on a year-long process that involved studying emerging standards in other professions and examining relevant professional literature, such as the Association of Social Work Boards' (2015) *Model Regulatory Standards for Technology and Social Work Practice*. In addition, Task Force members considered the technology practice standards that were concurrently being developed by a national task force commissioned by NASW, Council on Social Work Education, Clinical Social Work Association, and Association of Social Work Boards. A year later the proposed amendments were presented to the NASW membership for review, and many member comments were incorporated prior to finalization.

The approved *Code of Ethics* revisions reflect a collaborative and inclusive effort that drew from a diverse cross-section of the profession. The August 4 approval by the Delegate Assembly marks significant progress in the profession's ability to respond to our ever-changing practice environment.


